WORKSHOP OVERVIEW

Reliable, affordable electricity is essential to economic growth, energy security, and competitiveness across the American West. Yet, the region's aging grid and surging demand—from electrification, population growth, industrial and mining expansion, and data centers—are placing increasing pressure on transmission infrastructure. Transmission development in the West is uniquely difficult. Projects must align diverse utility and market structures, navigate local, state, tribal, and federal jurisdictions, and overcome financing and cost-allocation barriers, among other complexities.

As a result, high-value regional transmission projects are often delayed—or fail to advance at all—despite clear public benefits. In response, several states have created state authorities to plan, finance, coordinate, and develop transmission.

This workshop will examine how these state authorities are working to advance timely transmission development that is in the public interest. It will convene leaders from western state infrastructure authorities, policymakers, regulators, and practitioners to examine what is working, what is proving difficult, and what lessons are emerging.

OBJECTIVES

By the conclusion of the workshop, participants will:

- Understand the powers, duties, governance structures, and priorities of the Colorado, New Mexico, and Wyoming transmission authorities;
- Identify practical insights applicable to their own state policy, regulatory, or transmission development efforts; and
- Build relationships with peers across western states through structured cohort interactions and facilitated discussions.
